up for everyone — including the county.

The proposed ordinance lists rebate qualifying vehicles as automobiles, certain trucks, motorcycles, business vehicles, boat, cattle, horse, and car trailers, semitrailers and utility trailers.

The board cannot vote on the ordinance until after a public hearing, which is set for 7 p.m. Jan. 3, 2023 at the Middlesex County Historic Courthouse in Saluda.
